5. To ensure a convenient time of recording, booking must be made within 2 months of the voucher issue date.

7. Any extra services or studio time requested by the beneficiary of the voucher which are not covered by this voucher will be paid for in full by the purchaser or recording artist on the occasion of the recording taking place.

8. Recorded material will only be released to the beneficiary of the voucher on receipt of full payment for the services requested and carried out.

9. If services are delayed beyond the control of the studio, the beneficiary of the voucher will be offered other convenient dates. The studio takes no responsibility for ensuring that commercial or private deadlines are met in these circumstances.

10. Bookable hours are between 10 and 6, Monday-Friday excepting public and bank holidays. Weekends may be booked by prior arrangement. A surcharge will be made for a weekend booking.

11.Bookings should be made by telephone or email, stating the voucher number and details.

12. Any additional payments should be made to "Mantra CDs and Recording".

13. Beehouse vouchers are individually tracked an marked. Attempts to defraud the business by the forging or misuse of vouchers will be met with a full legal response.

14. If you change your mind about your purchase, please return the unused voucher to us with the receipt within 7 days, and we will offer you an exchange or a credit note.
